OTHER & FINAL PAYMENTS: Final payments are due 75 days prior to travel unless otherwise advised - Full details are available from your booking agent or Allways Dive Expeditions, the onus rests with you to contact us or your tour leader for these details. Sometimes we need to ask for additional installment payments from you to meet supplier booking conditions. These payments help us lock in your price and inclusions- we won't ask unless we have to. Please understand that we do everything possible to avoid these extra payments but often operators have their own payment conditions that differ from ours.
